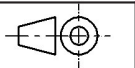
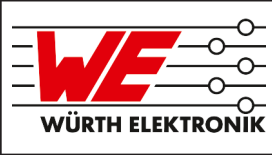
Storage Conditions:

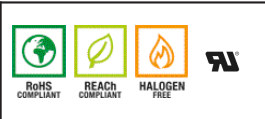
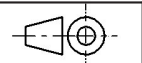
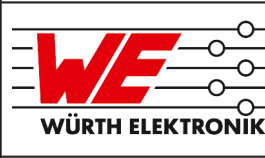
