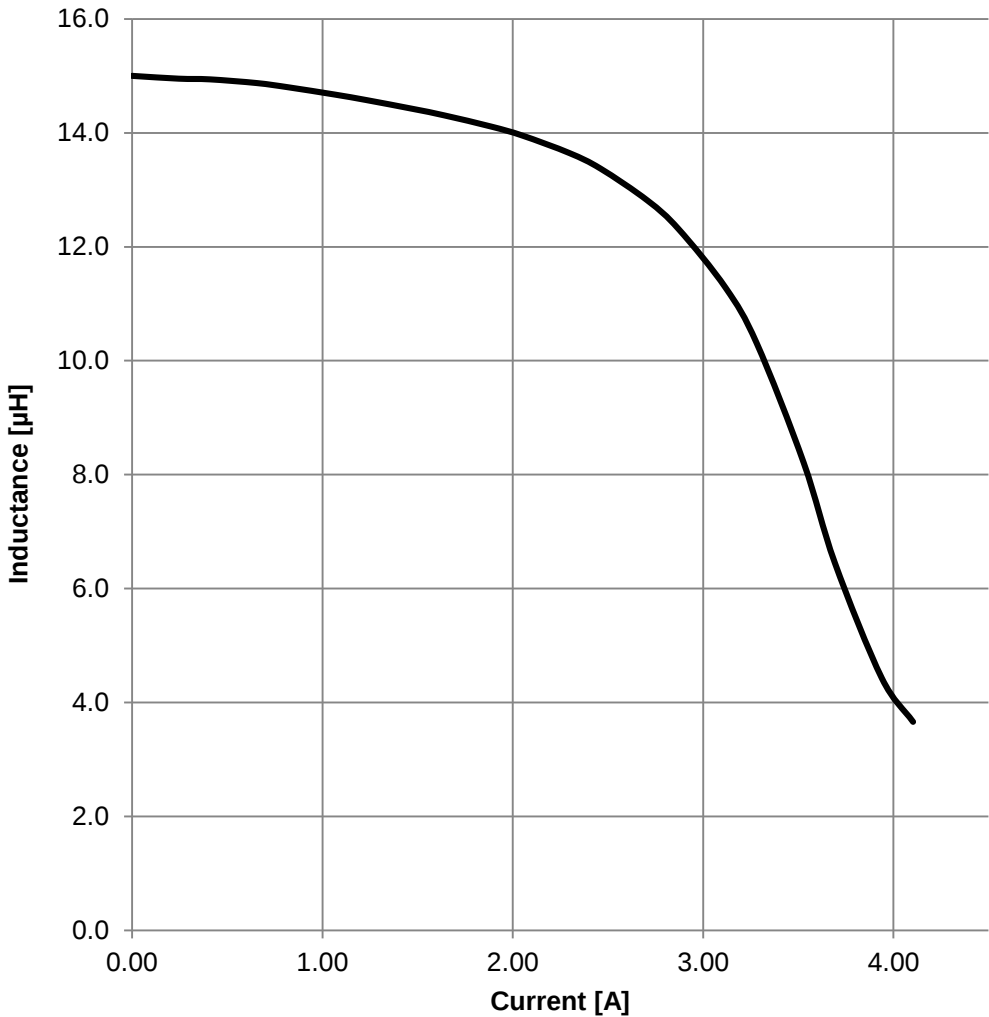

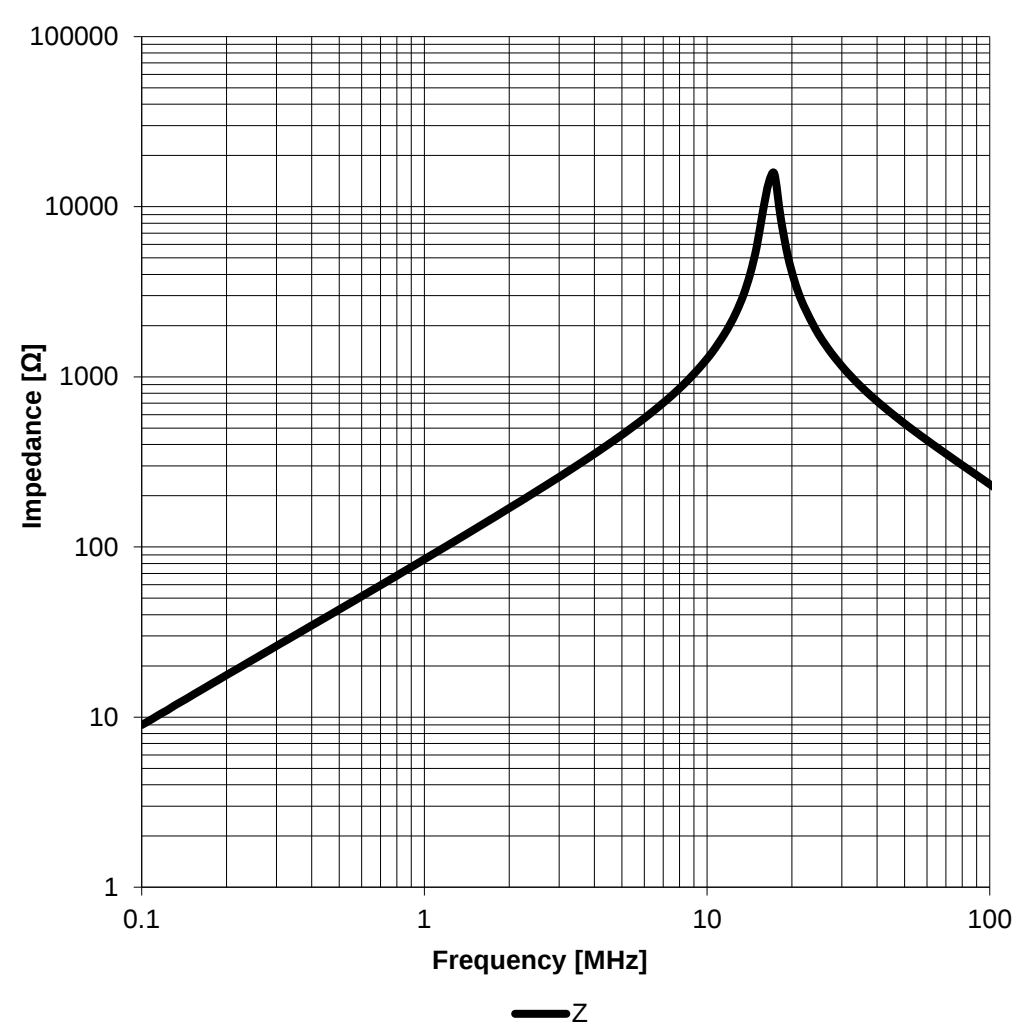

Soldering:

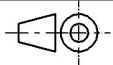
Packaging:
