

The VS-6CWQ03FN-M3 surface mount, center tap, Schottky rectifier series has been designed for applications requiring low forward drop and small foot prints on PC board. Typical applications are in disk drives, switching power supplies, converters, freewheeling diodes, battery charging, and reverse battery protection.




Fig. 1 - Maximum Forward Voltage Drop Characteristics (Per Leg)




Fig. 2 - Typical Values of Reverse Current vs. Reverse Voltage (Per Leg)




Fig. 3 - Typical Junction Capacitance vs. Reverse Voltage (Per Leg)




Fig. 4 - Maximum Thermal Impedance Z_{thJC} Characteristics (Per Leg)




Fig. 5 - Maximum Allowable Case Temperature vs. Average Forward Current (Per Leg)




Fig. 6 - Forward Power Loss Characteristics (Per Leg)





Fig. 7 - Maximum Non-Repetitive Surge Current (Per Leg)


